Matt & George,

I was at the committee meeting via zoom on Monday morning. The Brunson's and Boathouse would like the petition put on next zoning committee agenda as they have gone through the proper process for their petition including Town Board approval. As I listened to the reasoning for the postponement motion it was clear that some of the committee members thought what was proposed was not within the townships plan, which is simply not the case. I have attached the policy they adopted for their township for the A2 zoning. The only more restrictive policies for their outdated plan, is for the number of A3 lot splits allowed and a mineral extracting regulation ordinance.

It was stated that the A2 zone needs to be inside the township Hamlet which is simply not the case. In fact, the town of Concord and County approved 2 in the last year for A2 zoning outside the town Hamlet. One less than a half mile away for indoor boat storage and the Anfang property on Hwy P for S&R Egg.

In summation they did adopt the counties plan with only a few policies that are more restrictive and none of those are reflected in the A2 zone.
